The Tender Schedules will be sold from 10.00 AM 04.00 P.M. during working days from **09-05-18 to 29-05-18**. Last date for receipt of filled-in-tender schedules is **29-05-18 by 4.00 PM**. The Tender schedule will be opened in the office of the undersigned at 11.00 AM on **01-06-18** in the presence of the purchase Advisory Committee of JNV-Krishna and tenderers.
2. There should not be any over writings or corrections in the tender. If a figure is to be amended, it should be neatly scored out, the revised figure written above and the same attested with full signature and date. In the absence of attested signature the tender is liable to be rejected
3. On acceptance of tender, it will become a contract and contractor shall be bound by the terms & conditions.
4. The tenderer has to visit the vidyalaya monthly once for hair dressing work to students.
5. The tenderer has to use new balde to each student.
6. The tenderer has to submit the bill immediately after completion of hair dressing work to the students on monthly basis.
7. The undersigned does not bind him self to accept the lowest Tender and reserves the right to accept the Tender.
8. A demand draft for **Rs.500/-** drawn on any Nationalized Bank payable at **HANUMAN JUNCTION** in favor of "**The Principal, Jawahar Navodaya Vidyalaya, Veleru**", towards E.M.D. should be enclosed to the tender and the same will be returned to the unsuccessful tenderers. The successful tenderer is required to pay a further sum **of Rs.500/-** towards full amount of **Security Deposit of Rs.1000/-**. **The Security Deposit will be forfeited in the event of failure to comply with the contract.**
9. If the contractor fails to attend hair dressing work as per the contract agreement / as and when called, the undersigned shall be at liberty to engage the worker from the market or get the hair dressing work, the difference of price, if any shall be deducted from the Earnest Money/Security Deposit and in case any amount in excess of the Security Deposit is paid by the undersigned, the contractor shall be liable to pay this amount.
10. The rate quoted by the tenderer shall hold good **from 01.06.2018 to 30-03-2019 / 30.04.2019**. No amendment in the rate will be accepted during the period agreement.
11. The Vidyalaya shall retain the amount of Security Deposit for a period of one (01) month from the date of completion of agreement.
12. Tenders, which do not comply with the above conditions, are liable to be rejected.
13. No interest will be paid for Security Deposit during the period of Contract.
14. The Committee has the right to accept or reject the tender without assigning any reason.
15. The Vidyalaya Purchase Committee here the right to cancel any Tender at any time if the students are not satisfied with the quality of the work.
