The Tender Schedules will be sold from 10.00 AM 04.00 P.M. during working days from **09-05-18 to 29-05-18**. Last date for receipt of filled-in-tender schedules is **29-05-18 by 4.00 PM**. The Tender schedule will be opened in the office of the undersigned at 11.00 AM **on 01-06-18** in the presence of the purchase Advisory Committee of JNV-Krishna and tenderers.
2. There should not be any over writings or corrections in the tender. If a figure is to be amended, it should be neatly scored out, the revised figure written above and the same attested with full signature and date. In the absence of attested signature the tender is liable to be rejected.
3. The undersigned does not bind himself to accept the lowest Tender and reserves the right to accept the Tender in whole or in part, i.e. with respect to all the articles mentioned in the attached statement or in respect of any one or more than one articles specified in the attached statement as he may decide.
4. On acceptance of the Tender, it will become a contract and the contractor shall be bound by the terms and conditions of the tender.
5. A demand draft for **Rs. 2000/-** drawn on any Nationalized Bank payable at **HANUMAN JUNCTION** in favor of **"The Principal, Jawahar Navodaya Vidyalaya, Veleru"**, towards E.M.D. should be enclosed to the tender and the same will be returned to the unsuccessful tenderers. The successful tenderer is required to pay a further sum **of Rs.3000/-** towards full amount of **Security Deposit of Rs.5000/-**. **The Security Deposit will be forfeited in the event of failure to comply with the contract.**
6. If the tenderer fails to attend the **TAILORING WORK** within the stipulated time, theundersigned shall be at liberty to get the work completed by any other person, the difference of price, if any shall be deducted from the EMD/SD and in case aby mount in excess of the EMD/SD is paid by the undersigned, the contractor shall be liable to pay this amount.
7. The Vidyalaya shall retain the amount of Security Deposit for a period of one (01) month from the date of completion of supplies as safeguard against any defect appearing in the stitching of uniform or if not attending the stitching work with in the stipulated time. Tenderer which do not comply with the above conditions, are liable to be rejected.
8. No interest will be paid for Security Deposit during the period of Contract.
9. The Committee has the right to accept or reject the tender without assigning any reason.
10. The Vidyalaya Purchase Committee here the right to cancel any Tender at any time if the students are not satisfied with the quality of the work.
11. The tenderer should be enclosed a copy of main page (1st page) of bank pass book of firms/individual
12. The rate quoted by the tenderer shall hold good **from 01.06.2018 to 30-03-2019 / 30.04.2019**. No amendment in the rate will be accepted.
13. The payment shall be made in the form of Cheque / Bank Transaction.
14. Income Tax shall be deducted as per the Rules from time to time.
15. He/She shall engage the skilled workers required for stitching work at his/her own cost and shall start the stitching work in the 1<sup>st</sup> or 2<sup>nd</sup> week of June/July 2018 and complete the work within 30 days.
16. He/She shall do the stitching work in our vidyalaya premises and the items like sewing machine, tables, scissors etc will be arranged by his/her won cost.
17. He/She understands and agrees that only Uniform cloth will be supplied by the vidyalaya nd the **cost of good quality thread, buttons, zips, pocket cloth, cost of over lock where ever necessary etc.**, will be borne by the tenderer and the cost of the same are included in the rates quoted by tenderer.
